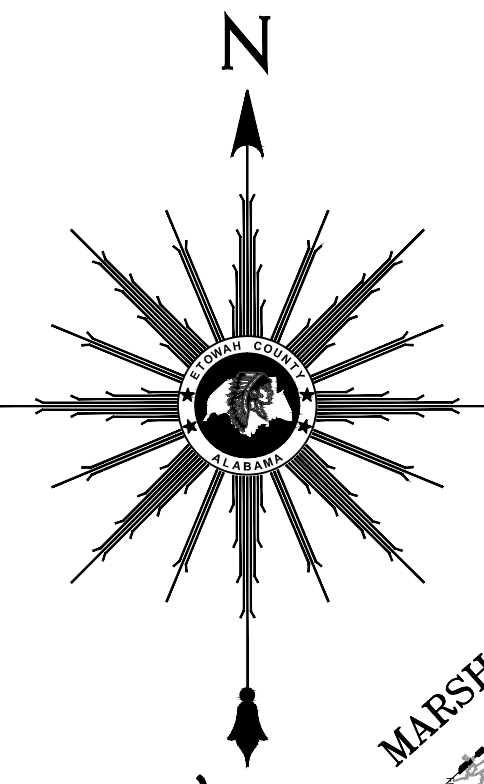

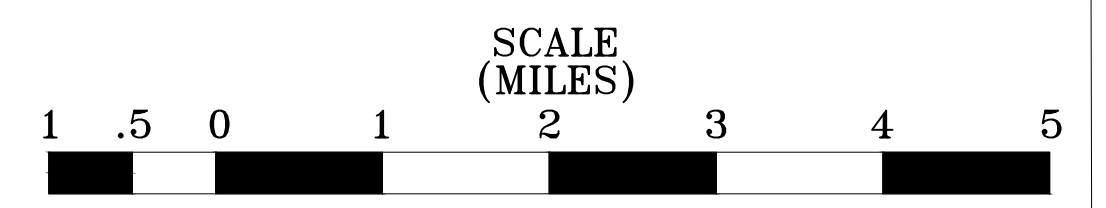

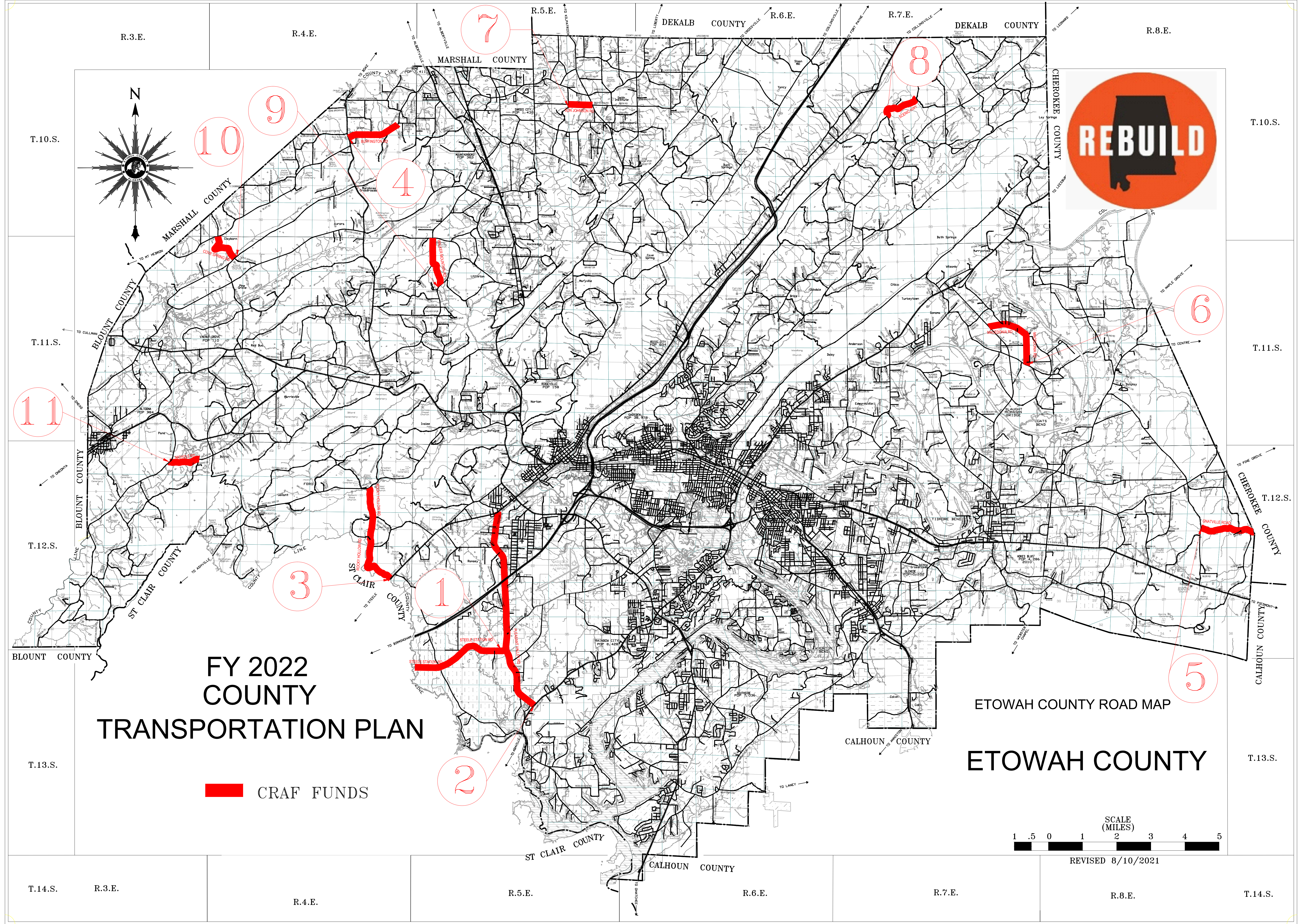
FY 2022 COUNTY TRANSPORTATION PLAN
